

मसाला चौक स्थित एम्फीथियेटर में जयपुर विकास प्राधिकरण द्वारा आयोजित
'कला प्रोत्साहन माह' में भाग लेने हेतु कलाकारों से आवेदन आमंत्रित

जयपुर के युवा कलाकार, जो संगीत, नृत्य, नाटक आदि को अपना लक्ष्य या शौक समझते हैं, उन्हें उनकी प्रतिभा प्रदर्शित अथवा व्यक्त करने के लिए जेडीए रामनिवारा बाग स्थित मसाला चौक के पास निर्मित एम्फीथियेटर (खुला मंच) उपलब्ध कराने जा रहा है।

शहर के कलाकार वर्ग को प्रोत्साहित करने की दृष्टि से जयपुर विकास प्राधिकरण एक 'कला प्रोत्साहन माह' का आयोजन कर रहा है, जो 9 जून से प्रारम्भ कर 1 जुलाई, 2018 तक होगा और उक्त अवधि के दौरान प्रत्येक शनिवार व रविवार को एम्फीथियेटर में इससे जुड़े कार्यक्रम आयोजित होंगे।

कोई व्यक्ति समूह या संस्था जो कला संवर्द्धन में कार्यरत है और उक्त 'कला प्रोत्साहन माह' में अपना हुनर लोकमंच पर पेश करना चाहते हैं, वे अपना आवेदन ईमेल sunilvyas.xen@gmail.com पर या व्यक्तिगत रूप से प्राधिकरण के कमरा नं.-102 में उक्त माह में प्रत्येक मंगलवार तक निर्धारित प्रारूप में दे सकते हैं। प्राप्त आवेदनों पर विचार कर उस सप्ताह के गुरुवार तक भाग लेने हेतु चयनित व्यक्तियों को कार्यक्रम के लिए सूचित कर दिया जाएगा, एवं उनका कार्यक्रम उस शनिवार/रविवार को होगा।

जयपुर विकास प्राधिकरण के 'एम्फीथियेटर' में 550 व्यक्तियों के बैठने की जगह है, वहाँ स्टेज व अन्य आवश्यक परिसर का भाग निशुल्क उपलब्ध कराया जाएगा। इसके अतिरिक्त मूलभूत रोशनी, ध्वनि, पीने का पानी, सुरक्षाकर्मी, साफ-सफाई आदि सेवा भी निशुल्क उपलब्ध कराई जाएगी।

**OUTLINE OF PROMOTIONAL MONTH BEING ORGANISED BY JDA AT AMPHITHEATRE,
RAMNIWAS BAGH IN JUNE 2018**

1. THE AMPHITHEATRE

JDA's newly developed amphitheatre is located in the historical Ramniwas Bagh, which also houses iconic places like Albert hall, museum Ravindra Manch, Zoo etc.

The amphitheatre, developed in 11000 Sqmts, has a seating capacity of 500 people and has beautiful garden, walk ways and sitting spaces attached to it. The amphitheatre abuts 'Masala Chowk' which has become a coveted eating destination and is a vibrant place especially in evenings.

2. ITS OBJECT :-

The prime object of developing the amphitheatre is to provide a stage to budding artists and the youth of the city. A very large number of youth cling to art /music /dramatics to pursue a career or hobby but they do not find a platform to exhibit their talent and achieve the initial acknowledgement. The JDA amphitheatre would provide a performing platform to all such aspiring artists to project themselves and surge ahead or to just vent their hidden talents and enjoy being an artist.

3. JDA'S INITIATIVE

JDA is organizing a 'promotional month', where the programs would be organised on weekends only starting from 9th June to 1st July where the stage would be provided free of charges to motivate and promote the budding artist of the city.

JDA would invite open applications from the young artists/ groups of the city who wish to perform.

3.1 WHO CAN APPLY

- 3.1.1** Any individual or group from Jaipur composed of young artists in field of music, singing, dance and drama.
- 3.1.2** Any Trust / society or other body promoting art/music/dance/drama etc
- 3.1.3** The individual or group should be serious art lover pursuing a career or hobby.
- 3.1.4** They should be preferably local i.e. belong to Jaipur.
- 3.1.5** They should have their own instruments of performance

3.2 WHEN AND HOW TO APPLY

- 3.2.1 An individual or group fulfilling above and desirous of performing during the promotional fortnight can apply online on mail ID : sunilvyas.xen@gmail.com in format attached before ^{5th} June 2018.

3.3 SCREENING AND EVENT PROGRAM

- 3.3.1 A committee of experts would screen the applications received and finalise the list of people who would perform during the fortnight. A daily program of the performances would be prepared and sent to selected individuals/ groups by 6th June though mail.

4. ENTRY/ PARTICIPATION

- 4.1 The entry to everyday program would be open to all and free. The performing artists are free to invite their fellow artists, families or known. However the right to admission is reserved with JDA

5. JDA'S OBLIGATION

- 5.1 JDA would publicize the promotional fortnight.
5.2 JDA would provide the stage free of cost.
5.3 JDA would provide facilities like security guards, cleaning, drinking water and electricity free of any charges.
5.4 JDA would provide basic stage lights and sound. Any additional lights or sound arrangement required shall be arranged by the group/ individual.

6. PERFORMING GROUP'S OBLIGATION

- 6.1 The group will bring their own costumes, instruments of performance etc.
6.2 The group shall arrange their own sound system suitable to the performance.
6.3 The group shall arrange lighting or sound system required over and above the basic lighting and sound provided by JDA
6.4 The group shall have to arrange and organize their set up and remove the same between 1.00 PM of the performance day and 1.00 PM of the next day.
6.5 The performing artist / group cannot impose any kind of ticket or charges and shall also be not allowed to sale any product / material there.
6.6 The artist/ group will ensure that the performance is purely art work and the content/ theme is not political or religious or against any community that may hurt anybody's sentiments.
6.7 Any issue arising out of the performance shall be sole responsibility of the performer. JDA shall not be liable for any such eventuality.

7. TIMING

7.1 The performance timings shall be from 8.00 pm to 9.30 pm

7.2 Depending on the duration of individual performance, it could be one or more performance on a day, which would be so accommodated in the program finalized.

8. SPONSORSHIP

8.1 Performing individual or group can seek sponsorship to meet the expenses. The sponsorer shall be allowed to display maximum two numbers of banners each being not larger than 4x8 fts in size apart from the stage backdrop or as approved by JDA.

8.2 The stage backdrop matter shall be got approved from JDA and JDA being organizer shall have appropriate place in the backdrop.

8.3 The sponsorer's display should not contain any banned / restricted advertisement or material and should not be obscene.
