**Agenda No.59/2000-1** : Regarding change in land use of the land bearing khasra no. 41,42, 43 village Sukhpuria, Tehsil Sanganer totaling 29191.25 square yards from "wholesale business warehousing and godown" use to "institutional"(Engineering college) use.

Agenda prepared by STP(CP) was discussed - It is clear that title has not been examined by Zone so far. After detailed discussions Committee decided the following:-

1. Applicant be asked to provide 60 feet wide road leading to land in question.
2. Similar to Balaji Trust <sup>le</sup> case of Engineering College, Committee agreed in principle for the change in land use of the land in question from "Wholesale business, warehousing and godowns" to "institutional (Engineering college)". Looking to the urgency a letter to this effect was issued to applicant on 29-06-2000 as per the demand of Secretary of National Society for Engineering Research and Development, Jaipur, the same was confirmed.
3. File be sent to Zone for title verification and technical examination.
