Approval of " Chitrakoot" residential Scheme

After considering the agenda item, the Committee accorded its approval with the following modifications:-

Para (3) of the Scheme Brochure-

- (i) Income categorisation was approved with the stipulation that approval of the State Govt. may be taken for the changes made. However, the upper income limit of Rs.7500/- p.m. for category E may be adhered to.
- (ii) Cost of land may be recovered at the rates mentioned in the U.L.T. (Urban Land Disposal) Rules and no further concession may be given

Para (6) of the Scheme Brochure-

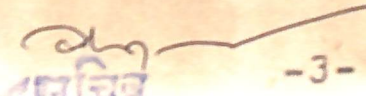
No instalments for recovery of cost of land may be made and it may be recovered in thirty days from the date of issue of Demand letter provided that the allottee may deposit the said amount within next 30 days but an interest @ 15% per annum shall be charged with effect from the date of allotment failing which the allotment shall automatically stand cancelled.

Para (10) of the Scheme Brochure-

The Committee approved the reservation of plots for various categories of applicants including SC/ST with the modification that 18% plots may also be reserved for State Govt. / ^{State} Govt. Undertaking employees as per provisions of Urban Improvement Trust (Disposal of Urban Land) Rules 1974 .

Para (11) of the Scheme Brochure-

Condition No.4 permitting one residential Unit on each floor may be deleted.

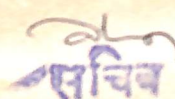
